Public Content

5 ILCS 120/2 provides the Governing Body with certain exceptions to the Open Meetings Act and allows for the conducting of a closed session. Provisions of 5ILCS 120/2(c)(5) specifically provide for a closed session to discuss the purchase or lease of real property for the use of the public body and 5ILCS 120/2.06 to review closed session minutes

It is the policy of the City of Sterling to conduct discussions relating to the purchasing or leasing of real property as well as reviewing closed session minutes in a closed session.

Therefore, the City Council should move by a simple majority vote to go into a closed session for the above purpose as provided for under 5 ILCS 120/2 and 5 ILCS 120/2.06.

No action will follow the closed session.
