Bucket Brigades throughout the fair-weather months have increased throughout the last few years. These code sections have been revised.

The following changes have been made:

- Eliminating the sentence regarding no delivery of items to persons contributing.
- The application is accepted by the City Clerk's office and will be placed on the agenda for approval.
- Solicitations will be limited to five locations in the downtown.
- Permitted locations are listed.
- Saturdays are the only permitted day.
- Each organization is allowed only one per year.
- Traffic cones shall be obtained from Public Works on Thursdays, because Public Works is closed on Fridays during the summer.

Although changes are not being made to the code, the following will be enforced:

- Solicitations will be scheduled on a first-come, first served basis.
- Solicitations will be scheduled every other week to allow for inclement weather.
- There will be only 12 solicitations be year.
